

Location

Sallins village is located along the Grand Canal approximately 3km from Naas, 28km south west of Dublin City Centre & 34km from Dublin Airport. Transport and communications are excellent with the M7 motorway providing direct access via the M50 and National motorway network. Sallins railway station provides numerous trains each day to Dublin (Heuston Station) as well as a regular bus service.
