LOCATION:

The lands enjoy an excellent location in North Co. Wexford, with some of the land having road frontage onto the R772, while the rest has frontage onto two local roads. It is 1km from Scarnagh crossroads, 6km from Arklow, 2km from Coolgreaney, 4km from Castletown and the coast, with Gorey only 12km away.

Gorey is one of the region's most noted towns and offers an excellent choice of schools along with a wealth of restaurants, shops, pubs, award winning hotels, cinema, theatre and a vast array of local leisure amenities such as endless sandy beaches, golf courses to include Courtown Golf and Ballymoney Golf Club, swimming and leisure centres. There are excellent daily commuter services in Gorey with Bus Eireann, Wexford Bus and the local train station. South Dublin is a comfortable commute of one hour.

DESCRIPTION:

All the lands have extensive road frontage with Lots 1 and 2 having good quality grassland, while the remaining Lots are in need of some improvement / investment works. Given the location, there may be site potential on some of the land, subject to the relevant planning permission being obtained. 
