The beautifully restored property which features a recently thatched roof, has many exposed beams and original features including a cosy, dual aspect sitting room with an inglenook fireplace and open fire plus a good sized kitchen/breakfast room with views over fields. The rear hall has two handy storage areas and leads to the spacious four piece bathroom with a useful utility cupboard whilst the first floor has the two, well proportioned bedrooms.

Externally, there is an attractive 100 ft wide x 30 ft deep garden which includes the frontage to the road, the two good sized side gardens and the terrace adjoining the fields to the rear. In addition, there is off road parking for 3 cars and a sheltered decked seating area enjoying the sweeping countryside views.




