With an array of seating areas, log burning stove and additional space for an eight person dining table, providing the perfect for entertaining guests or simply relaxing in style. The well appointed kitchen/breakfast room is complemented by a utility room, larder, and cloakroom, catering to practical needs with elegance, and from here there is direct access to the garden, providing perfect space to dine alfresco.

Upstairs, the generous principal bedroom features vaulted ceilings and exposed beams, dressing area, plentiful wardrobe space and en suite bathroom. Two further double bedrooms and a house bathroom complete the accommodation, all finished to a high standard and full of charm.

Externally, the property benefits from private parking via a carport, with ample road parking and enjoys moderate sized lawned gardens to the front and rear. The rear garden offers complete privacy with an open field aspect, creating a tranquil rural atmosphere.

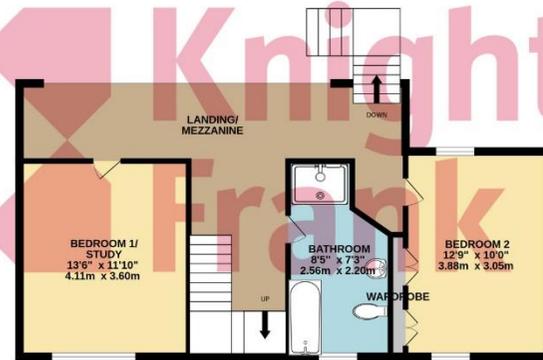




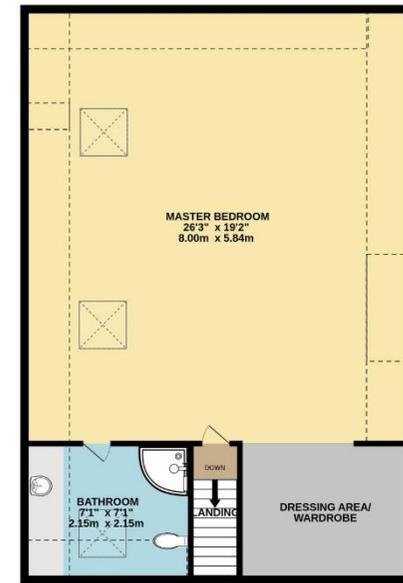
